- York University, its governors, trustees, officers and employees named as Additional Insured to these policies but only with respect to liability arising out of the operations of the Named Insured.
- It is agreed and understood that the deductible or self Insured retention (SIR) arranged between the Named Insured and the Insurer, must be declared herein and is subject to approval by York University's Risk Management Services. It is further understood and agreed that claims arising out of the operations of the above mentioned project which fall within the deductible or SIR limit are the sole responsibility of the Named Insured.
